ABOUT US

Generations United's National Center on Grandfamilies is a leading voice for families headed by grandparents, other relatives, and close family friends. The Center's work is guided by GRAND Voices, a national network of grandfamily caregiver advocates. Through the Center, Generations United leads an advisory group of caregivers and organizations that set the national agenda to advance public interest in support of these families. As trusted voices on Capitol Hill, center staff conduct federal advocacy and support grandfamilies to elevate their own voices to improve policies and practices that impact them. The Center provides training and tailored assistance to advocates and practitioners and raises awareness about the strengths and needs of grandfamilies through media outreach, weekly communications, and awareness-raising events. The Center releases an annual State of Grandfamilies report and a broad range of guides, fact sheets and tools for grandfamilies, which cover issues from educational and health care access to financial and legal supports. Generations United is also home to the Grandfamilies & Kinship Support Network, the first-ever national technical assistance center for those who serve grandfamilies and kinship families supported through a cooperative agreement with the U.S. Department of Health and Human Services' Administration for Community Living. 🚹 Sets Collective Agenda

Through the convening of national symposiums of experts in the grandfamilies field, the Center has led efforts to set a united agenda and coordinate the collective work of national leaders working on behalf of grandfamilies.

2 Elevates Grandfamily Voices

Generations United's GRAND Voices is a national group of grandparents and other relatives raising children, with representation from virtually every state and many tribes, that guides the work of the Center. We support, train and engage GRAND Voices and young people raised in grandfamilies to inform policies and practice, address service gaps, and advocate for better outcomes.

Advocates for Policy Change

As a trusted voice on Capitol Hill, the Center advocates for improved policies for grandfamilies including through child welfare reform, specialized federal housing assistance, and the inclusion of grandfamilies in the Older Americans Act.

🚹 Promotes Positive Messaging

Generations United's is the go-to group for media seeking expert commentary on grandfamilies. Our awareness raising efforts have resulted in coverage in the Wall Street Journal, Washington Post, New York Times, NPR and ABC News. Our communications efforts led to reframing the way we talk about families, leading with strengths and moving the term grandfamilies into the country's vernacular.

KEY ACCOMPLISHMENTS

- Held first convening of kinship experts resulting in the first national action 1997 agenda
- Established the National Center on Grandparents and Other Relatives 1998 Raising Children (later renamed National Center on Grandfamilies)
- Testified before U.S. Senate HELP Committee which led to the inclusion of 2000 grandfamilies in the National Family Caregiver Support Program in the Older Americans Act
- 2003 First National GrandRally held in Washington DC & Legacy Intergenerational Housing Act passes
- Second National GrandRally leads to introduction of Kinship Caregiver 2005 Support Act
- 2008 Third National GrandRally, Fostering Connections to Success and Increasing Adoptions Act passes
- Wall Street Journal uses term grandfamilies in front page headline 2009 "Grandfamilies Come Under Pressure"
- Fourth National GrandRally helps protect Social Security for All Ages 2011
- 2014 Co-created the first set of national model family foster home licensing standards, established the annual Grandfamilies Champion Award
- Established GRAND Voices, now representing virtually every state and 2015 many tribes and influencing policy, practice, and perception across the country
- Fifth National GrandRally leads to introduction of Supporting Grandparents 2017 Raising Grandchildren Act, Generations United testifies before Senate Aging Committee about Grandparents Raising Grandchildren in the Opioid Crisis
- Testified before House Ways and Means Committee, Subcommittee on 2019 Social Security, Advisory Council to Support Grandparents Raising Grandchildren is established, Council is co-chaired by Generations United and includes five GRAND Voices as council members
- Advisory Council to Support Grandparents Raising Grandchildren releases its initial report to 2021 Congress & National Technical Assistance Center on Grandfamilies and Kinship Families is included in American Rescue Plan Act, Generations United establishes Grandfamilies & Kinship Support Network: National Technical Assistance Center
- 2022 Testified before Senate Aging Committee about Strengthening Support for Grandfamilies during the COVID-19 pandemic & beyond
- Kinship Unity Convening & Action Agenda Released 2023
- The Pathways to Success: K-12 Education Support for Kinship and Grandfamilies 2024 State 2024 of Grandfamilies and Kinship Care Report was released along with an interactive website.
